

College Council Meeting Summary • November 12, 2018

Welcome (President Carlston)

Called the meeting and welcomed everyone

Meeting Minutes (President Carlston)

No corrections were made. Jake Dettinger motion to approve. Paul Tew seconded, and all voted in favor.

Policy 304 (Vice President Dettinger)

- This is an old HR policy, which is no longer needed with Policy 101. No comments were received
- Garth Sorenson made a motion to approve. Larry Smith seconded the motion. All voted in favor.
- Action: Vice President Dettinger will present to the trustees.

ADA Compliance Policy (Vice President Dettinger)

- Paula Robison said this is an attempt to be aggressive and comply with policy while respect the time constraints of faculty
- President Carlston said the policy is the driver, but the real reason we will make these changes is student success
- Jason Springer made a motion to remove 4.3 "The committee should include people." Heidi Johnson seconded the motion, and it passed unanimously.
- Garth Sorenson made a motion to review 4.6, the appeal process, with legal counsel, send it back to College Council, and then out for the 30-day review. The motion was seconded by Larry Smith and passed unanimously.
- Action: Vice President Dettinger will get feedback from Morris for 4.6, circulate to CC, with approval, out for 30-day

Social Media Policy (President Carlston)

- Reviewed the policy, which is more concise
- Larry Smith and Allan Stevens offered several edits including:
 - In 3.7 end after the word "policy," correct the grammar, and strike "embarrassing to any person or entity"
 - o In 3.1 add apostrophe
 - o Consider editing 4.0, which is humorous
 - Change portion of the policy to guidelines
 - In 3.2 remove the word "your"
- Heidi Johnson made a motion to send the policy out for 30-day review after edits have been made. Craig Mathie seconded the motion, ad all voted in favor.
- Jason Springer guestioned use of word "employee representative" and the group agreed to remove it
- Action: John Stevens will edit and send out for the 30-day employee review

Human Resource Training and Compliance (President Carlston)

- Advice issue, not policy
- HR Audit revealed that employees are not completing trainings -- want everyone to feel safe and not offend people
- Complimented Josh and HR for their work on trainings
- Allan Stevens said supervisors need to have information to know who is completing trainings
- Heidi Johnson asked for timing considerations
- Action: Jake Dettinger will work with HR to do a manual notifications

College Council Meeting Summary • November 12, 2018

Budget Discussion (Vice President Dettinger)

- Lower enrollment than expected, exploring budget options: use on-going rainy-day fund, soft freeze, use carry forward straight across, or take volunteers to contribute portion of their budget
- Vice President Dettinger will take this to the budget task force
- President Carlston said we need to have an increase in enrollment; cabinet looked at ways to bolster enrollment (more
 personalization, part-time help, increase marketing efforts)
- Garth Sorenson said he feels like everyone should participate
- Jason Springer suggested three-tiers for budget solution: 2.5% across board, donations, and X% of carryover
- President Carlston said this will be a one-time impact on budgets and added thecaveat of needed growth

Enrollment Management Update (Vice President Mathie)

• Provided updated numbers on enrollment and the reorganization

Richfield Housing RFP Update (Vice President Mathie)

- Informed the group that no one responded to RFP
- The committee will look at next possible steps

Academic Policies Update (Vice President Hood)

Will work with faculty leadership to continue the A&T document through the process
